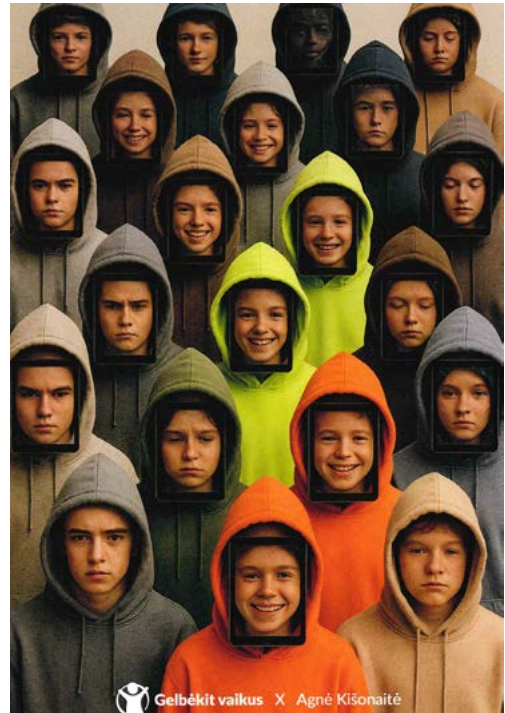
Survey

In May–June of this year, a survey was conducted with 1,165 children aged 10–18. The results provide valuable insights into the emotional well-being of young people today. On average, respondents rated their emotional well-being at 6.8 out of 10. Many children expressed a desire to experience self-confidence, calmness, and joy more often, while also highlighting challenges in coping with anger, sadness, anxiety, and feelings of inadequacy.

When describing how adults support them in difficult moments, children most often mentioned the importance of attentive listening, comfort and reassurance, presence, kind words, and gestures of care such as hugging, as well as acceptance of their emotions. At the same time, they emphasized what should be avoided: shouting, anger, blame, comparisons with others, or dismissive phrases like **“it’s nothing”** or **“stop crying.”**

In addition to these findings, the children generously shared many of their own personal stories and experiences, giving further depth to the survey.

Installation



To bring these voices to life, the project will feature an installation of 12 life-sized figures of children (ranging from 134–180 cm in height). A part of the installation will be displayed at the Congress venue on 6 October. From 7 October onward, the complete installation will be open to the public at Vokiečių St. 4 in Vilnius Old Town, where participants are warmly invited to experience it in full.

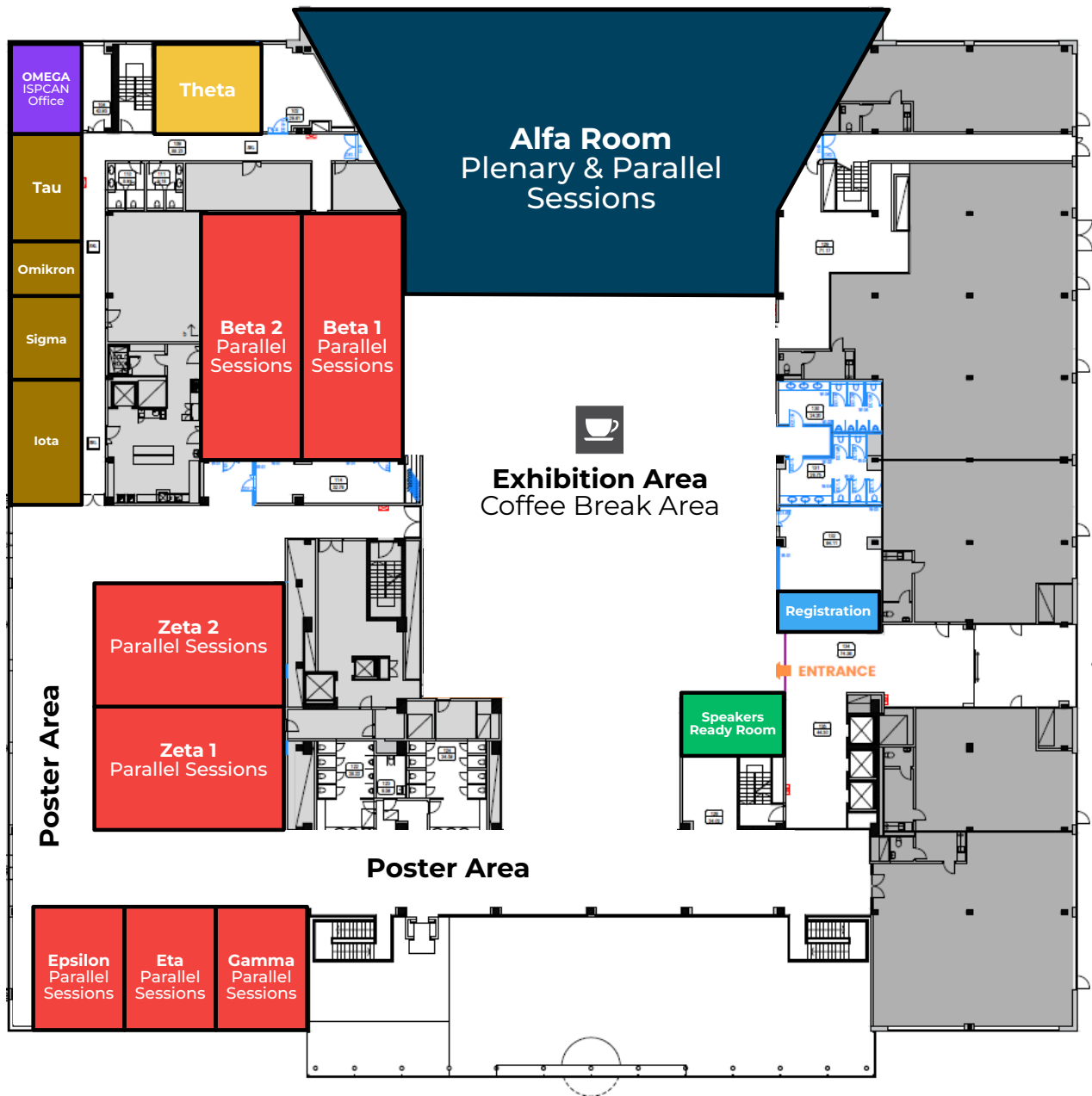
